# 1 EIS submissions summary

Bowen Basin Coal Pty Ltd (Bowen Basin Coal) proposes to extend the existing Lake Vermont Mine by developing the Lake Vermont Meadowbrook Project (the Project). The Project proposes underground longwall mining and an open-cut satellite pit, to mine coal seams to the immediate north of the existing Lake Vermont Mine. The Project is located approximately 25 km north of Dysart and 160 km south-west of Mackay, in the Bowen Basin region of central Queensland.

An Environmental Impact Statement (EIS) has been prepared for the Project in accordance with the *Environmental Protection Act 1994* (EP Act). The EIS is currently being assessed under the bilateral assessment agreement (between the State of Queensland and the Commonwealth of Australia). The EIS was publicly notified (with submissions invited) during the period April-May 2023.

## 1.1 Analysis of submissions

Resultant of the public notification of the EIS, 339 submissions were received. Of these submissions, 79 were considered improperly made (by the Department of Environment & Science). Improperly made submissions were largely resultant of a failure of the submitter to sign a submission, or a failure of the submitter to provide sufficient contact or address details. Notwithstanding this, all 339 submissions have been considered for the purposes of preparing this EIS submissions summary.




Figure 1: Overview of submission origins

Of the total 339 submissions received, 86% of these originated from within Queensland. Although the Project is Queensland-based, it did receive attention from a range of regions (Figure 1) including overseas submissions (3%, or 9 submissions), New South Wales (1%, or 3 submissions) and the Australian Capital Territory (1%, or 3 submissions).




Figure 2: Overview of submission views

Importantly, the majority of submissions (91%, or 309 submissions) supported the proposed development of the Project (Figure 2). Submissions in support of the Project were primarily received from direct Project stakeholders, including employees, contractors, suppliers and local residents of the Dysart area. Comments from governmental stakeholders accounted for 19 submissions, with 10 of these providing detailed comments on Project elements, while the remaining 9 acknowledged the Project EIS, whilst providing 'nil' comment.

Objections on the Project were received from 9 submitters (representing 3% of the total submissions). Objections were primarily from non-governmental organisations, environmental groups and one concerned individual. Objections to the Project were primarily related to climate change and greenhouse gas emissions, environmental impacts, as well as general concern with mining and/or coal mining.




Figure 3: Overview of the issues raised by submissions

Categorisation of the area of interest of each submission, was also undertaken (Figure 3). Of the total 339 submissions, social and economic benefits were identified as being of primary interest to submitters.
